Thank you for entering the 2010 Nebraska Open. We welcome you as a contestant and hope your experience of playing in this tournament will be enjoyable and one you remember.

Date: Friday, September 10 through Sunday, September 12

Location: Elks Country Club, 5113 63rd Street, Columbus, NE

Directions: Take I-80 to Exit 353 (York). Go north 53.4 miles on Highway 81 to 8th Street in Columbus. Continue north on Highway 81 as it winds through town and joins Highway 30. Continue to 48th Avenue. Turn right on 48th Avenue and go north about 2.5 miles to the entrance on your left.

Notice of Withdrawal: If you must withdraw, notify the NGA office immediately. Please call Craig Ames at (402) 505-4653, ext. 102.

Format: Stroke Play – 54-Holes.

Saturday, September 11, Second Round

Any amateur golfer that would qualify for the professional cut or any amateur golfer within 10 strokes of the amateur leader for the first 36-holes will continue play September 12; remainder eliminated after 36-holes.

Sunday, September 12, Third Round

Starting Times: Groupings and starting times for the first two rounds will be available on Tuesday, September 7th. Check the Nebraska PGA web site at nebraskapga.com or call the NGA office at (402) 505-4653, ext. 0. Final round groupings and starting times will be based upon score and order of return.

Practice Rounds: If desired, those entered may contact Elks Country Club Golf Shop at (402) 564-4930 to arrange a practice round (\$20) at an available time prior to the event. Please note—due to Thursday's Pro-Am, practice rounds, if any, will be limited to the morning.

Registration: There is no formal registration on site. You should arrive at the first tee no less than five minutes prior to your starting time. Complimentary range balls will be available for warm-up prior to your tournament round.

Awards: An awards presentation will take place Sunday after all scores are posted. A trophy will be awarded to the overall champion and low amateur. In addition, merchandise gift certificates will be awarded to the top amateur finishers.

Dress Code: Players must be neat in appearance with respect to clothing and personal grooming. The committee in charge will determine whether this requirement has been met, and has authority to withdraw the entry of a player who does not comply. Golf spikes with metal of any nature are not allowed.

Golf Balls: Only brands of golf balls on the most current USGA List of Conforming Golf Balls may be used. The One Ball Rule is not in effect.

Clubs: The condition of competition regarding grooves and/or punch marks will not be in effect.

Transportation: Automotive Transportation is permissible.

Distance Measuring Devices: The use of distance measuring devices is permitted.
