### **Eligibility**

Entries are open to amateur golfers who will have reached their fiftieth birthday by June 1, 2010. Entrant must be a resident of Nebraska and a member of the Nebraska Golf Association. If necessary, the field may be limited to the lowest active USGA Handicap Indexes as of the fourth revision, dated May 26, 2010.

**Amateur Status:** All players must conform with the USGA Rules of Amateur Status as specified in the USGA Rules of Golf.

### **Entries; Form, Fee, Closing Date**

All players shall apply on NGA forms. Forms may be obtained from the NGA office or NGA web site ([www.nebgolf.org](http://www.nebgolf.org)).

*Entry fee of \$125 shall be paid by every player. Entry fee will be refunded regardless of reason if the NGA (402-505-4653) is notified before the close of entries. After the close of entries, fee will be refunded in the case of injury or illness, if requested by May 31. No refund for any reason after May 31. A \$25 service charge will be deducted from all refunds.*

Late applications are not acceptable and will be automatically rejected. (Entries by telephone, telegraph, or FAX not acceptable.) Time limit for entries means time of receipt at NGA (not time entry is sent to NGA). Entries should be submitted early to allow ample time for delay or error in transmission. The risk of delay or error in transmission lies solely with the entrant and the NGA shall have no liability with respect to any such delay or error and the consequences therefrom, including rejection of the entry.

### **Format; Schedule; Divisions**

Stroke Play – 36 Holes.

TUESDAY, JUNE 1, First Round, 18-holes.

WEDNESDAY, JUNE 2, Second Round, 18-holes.

CHAMPIONSHIP: Golfers 50-57 and those 58 and older that elect to play from the championship tees will be eligible for the championship division.

AGE DIVISIONS: In addition to the championship, players will compete in gross and net competitions in the following age groups: 50-57 (championship tees); 58-64 (middle tees) and 65 and over (forward tees). Golfers 50-64 that elect to play net only will compete from the forward tees and are eligible for net prizes only.

*Any tie for first place will be played off immediately, hole by hole, until a winner is determined.*

### **Prizes**

CHAMPIONSHIP

WINNER: Crystal Bowl and custody of the Nebraska Senior Amateur Championship trophy.

AGE DIVISIONS (50-57; 58-64 & 65 and over)

GROSS & NET WINNERS: Crystal Award.

GROSS AND NET MERCHANDISE PRIZES: TBA

### **Rules of Golf; Close of Competition**

Play will be governed by the Rules of Golf as approved by the USGA. Questions shall be settled by the Championship Committee, whose decision shall be final. Competition will have closed when the Championship trophy has been presented.

### **Golf Balls**

Only brands of golf balls on the most current USGA List of Conforming Golf Balls may be used. This list is updated monthly and may be found on the USGA web site at [www.usga.org](http://www.usga.org) or by contacting the USGA technical Department at (908) 234-2300.

### **Footwear**

It is a condition of the competition that shoes with traditionally-designed spikes (regardless of composition, i.e., ceramic, plastic, etc.) or spikes, regardless of design, comprised either entirely or partially of metal (if such metal may come in contact with the course) are prohibited during the stipulated round. Penalty for breach of this condition: DISQUALIFICATION.

### **Caddies**

A player may provide his own caddie. If he wishes the host club to furnish a caddie, he should ask the NGA because sufficient caddies may not be available at the host club.

### **Publicity and Promotion**

By submitting an application, the player agrees to allow the NGA to use the player's photographic/video image for any NGA media related use(s).

### **Score Posting**

All Championship scores will be posted for handicap purposes. Players should not post these scores individually.

### **Transportation**

Automotive transportation is permissible.

### **Time of Starting**

Note under Rule 6-3 and Optional Condition as prescribed in Appendix I shall be in effect.

### **Practice Privileges**

Information regarding championship practice rounds may be found on the championship web site beginning April 1, 2010.

### **Conditions; Schedules**

The NGA Tournament Committee reserves the right to alter any of the conditions and schedules herein. The decision of the NGA Tournament Committee in any matter shall be final.

### **Personal Appearance**

Players must be neat in appearance with respect to clothing and personal grooming. The Committee in charge shall decide whether this requirement has been met, and has authority to withdraw the entry of a player who does not comply.

### **Tournament Information**

A memo to contestants including groupings and starting times will be mailed or e-mailed after the close of entries. If you have not received a memo within four days of the Championship, it is your responsibility to contact the NGA Championship Department.
