# NOTICE TO PLAYERS

(This notice supplements the Local Rules and Conditions of Competition for NGA Championships)

### **Abnormal Course Conditions:**

Flower Beds and their Rock Borders are deemed to be ground under repair even though not so defined by white lines.

<u>Flower Beds that are Surrounded by a Cart Path</u> (including everything growing within that area) and the cart path are treated as a single abnormal course condition when taking relief under Rule 16.1.

Areas of Netting Associated with Reseeding of Grass are deemed to be ground under repair even though not so defined by white lines.

### **Deciding Ties:**

In the case of a tie for first place, concerned sides shall immediately play-off hole-by-hole until the winner is determined. The play-off will begin on hole #1 unless otherwise notified by the Committee.

### **Dropping Zones:**

<u>Hole #8 Yellow Penalty Area</u> - If a ball is in the yellow penalty area on Hole #8, including when it is known or virtually certain that a ball that has not been found came to rest in the penalty area, the player has these relief options, each for one penalty stroke: 1) Take relief under Rule 17.1; or 2) As an extra option, drop the original ball or another ball in the dropping zone marked <u>"DZ" located on the forward teeing area</u>. The dropping zone is a relief area under Rule 14.3.

<u>Hole #14 Yellow Penalty Area</u> - If a ball is in the yellow penalty area on Hole #14, including when it is known or virtually certain that a ball that has not been found came to rest in the penalty area, the player has these relief options, each for one penalty stroke: 1) Take relief under Rule 17.1; or 2) As an extra option, drop the original ball or another ball in the dropping zone marked <u>"DZ" located on the forward teeing area</u>. The dropping zone is a relief area under Rule 14.3.

<u>Hole #15 Red Penalty Area</u> - If a ball is in the red penalty area in front of the teeing area on Hole #15, including when it is known or virtually certain that a ball that has not been found came to rest in the penalty area, the player has these relief options, each for one penalty stroke: 1) Take relief under Rule 17.1; or 2) As an extra option, drop the original ball or another ball in the dropping zone marked <u>"DZ" located on the</u> <u>forward teeing area</u>. The dropping zone is a relief area under Rule 14.3.

<u>Hole #15 Yellow Penalty Area</u> - If a ball is in the yellow penalty area near the green on Hole #15, including when it is known or virtually certain that a ball that has not been found came to rest in the penalty area, the player has these relief options, each for one penalty stroke: 1) Take relief under Rule 17.1; or 2) As an extra option, drop the original ball or another ball in the dropping zone marked <u>"DZ" located in the fairway</u>. The dropping zone is a relief area under Rule 14.3.

<u>Hole #16 Yellow Penalty Area</u> - If a ball is in the yellow penalty area on Hole #16, including when it is known or virtually certain that a ball that has not been found came to rest in the penalty area, the player has these relief options, each for one penalty stroke: 1) Take relief under Rule 17.1; or 2) As an extra option, drop the original ball or another ball in the dropping zone marked <u>"DZ" located on the forward teeing area</u>. The dropping zone is a relief area under Rule 14.3.

## Out of Bounds:

Out of Bounds is defined by perimeter fences in addition to white stakes and lines. When lines are present, the line itself is out of bounds.

Hole #3 - Out of Bounds is defined by the rock wall in addition to white stakes and perimeter fence.

Hole #5 - Out of Bounds is defined by the chain link fence left of the teeing area in addition to white stakes.

Out of Bounds is defined by the curbing of public roads in the following areas:

Hole #5 - Road behind the green; Hole #7 - Road left of the teeing area; Hole #8 - Road along the right and behind the green; Hole #10 - Road behind the green; Hole #12 - Road behind the green; Hole #16 - Road along the right; Hole #17 - Road left of the green. A ball is out of bounds when it lies beyond the curbing.

#### Penalty Areas:

<u>Red Penalty Area Hole #15</u> - The part of the red penalty area immediately adjacent to the cart path along the right is defined by the outer edge of the cart path between the two red stakes.

# Scoring Area:

<u>A Scorecard is Deemed Submitted</u> once the player has left the scoring table.

## Teeing Area:

The NGA Tee-Markers define the teeing ground.
