NOTICE TO PLAYERS

(This notice supplements the Local Rules and Terms of Competition for NGA Championships)

Abnormal Course Conditions:

Decorative Flower and Plant Beds are deemed to be ground under repair even though not so defined by white lines.

<u>Turf Nursery located right of hole #18</u> is ground under repair from which play is prohibited. If interference exists, relief must be taken. Such nursery is not defined, but it constitutes all of the area cut at approximately putting green height or less.

Drop Zones:

If a ball is in the following penalty areas, including when it is known or virtually certain that a ball that has not been found came to rest in the penalty area, the player has these relief options, each for one penalty stroke: 1) Take relief under Rule 17.1; or 2) As an extra option, drop the original ball or another ball in the dropping zone marked "DZ" in the location below. The dropping zone is a relief area under Rule 14.3.

<u>Hole #1 Yellow Penalty Area</u> - Drop Zone located near the yellow penalty area. <u>Hole #5 Yellow Penalty Area</u> - Drop Zone located on the forward teeing area. <u>Hole #6 Yellow Penalty Area</u> - Drop Zone located on the forward teeing area. <u>Hole #7 Yellow Penalty Area</u> - Drop Zone located on the white teeing area. <u>Hole #10 Yellow Penalty Area</u> - Drop Zone located near the yellow penalty area short right of the putting green. <u>Hole #13 Yellow Penalty Area</u> - Drop Zone located in the fairway.

Integral Objects:

Paint marks (e.g. dots to indicate the front and back of putting greens): Relief without penalty is not available.

Loose Impediments:

Wood chips, pine straw and mulch are loose impediments.

Obstructions:

<u>Birdhouses</u> and their posts are immovable obstructions.

Flower and plant beds enclosed by cart paths or adjacent to immovable obstructions are deemed to be part of the obstruction.

Immovable obstructions adjacent to each other are to be treated as a single obstruction.

Staked Trees (including tree wells associated with staked trees) are deemed to be immovable obstructions.

Out of Bounds:

Out of Bounds is defined by the perimeter fence, white dots and white lines in addition to white stakes.

Temporary Immovable Obstructions (TIO):

NGA tents, cooler stands, sponsor and tee signs, and the fan near the putting green on hole #11 are deemed to be a Temporary Immovable Obstructions (TIO). Relief may be taken on either side.

Deciding Ties:

In the event of a tie for 1st place, a hole-by-hole play-off will take place to determine the champion. Play shall commence at the 1st tee immediately following conclusion of the final round unless otherwise notified by the Committee. The play-off rotation will be holes 1-2-18 repeated, unless otherwise notified by the Committee.

Scoring Area:

Scoring Area – A scorecard is deemed to be returned when the player has left the area under the scoring tent.

Teeing Ground:

The Red NGA Tee-Markers define the teeing ground for the competition.

Transportation:

During the round, a player or caddie must not ride on any form of motorized transportation except as authorized or later approved by the Committee. A player who will play, or has played, under penalty of stroke and distance is always authorized to ride on motorized transportation.
