PRACTICE ROUNDS: Can be arranged at a time convenient to the club, for a fee of \$14 (walking) or \$30

(with cart) by contacting the golf shop at Indian Trails - (402) 528-3404.

STARTING TIMES: Starting times will begin at 8 a.m. off the first tee, and will be posted following the

May 19 deadline.

PRACTICE FACILITIES: Practice areas will open at 7 a.m. Range balls are complimentary and will be

available on the practice tee.

REGISTRATION: Formal registration will begin at 7 a.m. inside the main entrance of the clubhouse.

Players are required to check in prior to their start time. Please check in

before heading to the practice facilities.

FOOD & BEVERAGE: The clubhouse will be open for food and beverage service. Players may pay cash

or use a credit card for purchases.

CADDIES: A player may provide her own caddie. *Exception: A player may NOT use a parent*,

step-parent, or a quardian as a caddie.

TRANSPORTATION: Transportation is prohibited during the round. Players and caddies shall walk at all

times during the round unless otherwise specified by the Committee.

Pull/push carts are permitted.

SPECTATORS: Spectators are allowed and encouraged to follow a golfer. <u>Per USGA guidelines</u>,

the use of golf carts for spectators is prohibited.

GROOVE STANDARDS: It is a requirement that a player's clubs conform to the groove specifications

provided in the Rules of Golf. An Equipment Database is found at usga.org.

RANGEFINDERS: The use of Distance Measuring Devices is <u>permitted</u>.

DRESS CODE: Players and caddies must be neat in appearance with respect to clothing and

personal grooming.

FOOTWEAR: Local Rule as prescribed in Section 8 of the Committee Procedures is in effect.

Model Local Rule G-7.

GOLF BALLS: Any ball used in making a stroke must be on the current List of Conforming Golf

Balls issued by the USGA. The list is regularly updated and is found at usga.org.

The "One Ball Rule" is in effect, see Model Local Rule G-4.

PACE OF PLAY: Qualifying participants must play at a prompt pace of play and in accordance with

guidelines included in the post deadline packet.

EVACUATION PLAN: In the event of a suspension of play during the qualifier, players must

adhere to the evacuation plan included in the post deadline packet.

PLAY-OFF: In the event of a tie for the last qualifying place, or either of the alternate

positions, there will be a hole-by-hole play-off to determine place winners and alternates. Any announcements regarding the play-off will be made at the public

scoreboard upon completion of the qualifying round.

QUALIFIER PLACES: Qualifying places will be announced after the May 19 deadline.

LOWEST SCORE: Silver medal, if a tie, duplicate medals will be awarded.
