- PRACTICE ROUNDS:** Can be arranged at a time convenient to the club, for a fee of \$14 (walking) or \$30 (with cart) by contacting the golf shop at Indian Trails - (402) 528-3404.
- STARTING TIMES:** Starting times will begin at 8 a.m. off the first tee, and will be posted following the May 19 deadline.
- PRACTICE FACILITIES:** Practice areas will open at 7 a.m. Range balls are complimentary and will be available on the practice tee.
- REGISTRATION:** Formal registration will begin at 7 a.m. inside the main entrance of the clubhouse. Players are required to check in prior to their start time. Please check in before heading to the practice facilities.
- FORMAT:** Stroke play competition conducted over 18-holes.
- FOOD & BEVERAGE:** The clubhouse will be open for food and beverage service. Players may pay cash or use a credit card for purchases.
- CADDIES:** A player may provide her own caddie. *Exception: A player may NOT use a parent, step-parent, or a guardian as a caddie.*
- TRANSPORTATION:** Players and caddies must not ride on any form of transportation during the qualifying round unless authorized by the on-site Rules Committee. Pull/push carts are permitted.
- SPECTATORS:** Spectators are allowed and encouraged to follow a golfer. Per USGA guidelines, the use of golf carts for spectators is prohibited.
- GROOVE STANDARDS:** It is a requirement that a player's clubs conform to the groove specifications provided in the Rules of Golf. An Equipment Database is found at [usga.org](http://usga.org).

- DRESS CODE:** Players and caddies must be neat in appearance with respect to clothing and personal grooming.
- FOOTWEAR:** Local Rule as prescribed in Section 8 of the Committee Procedures is in effect. Model Local Rule G-7.
- DRIVERS/GOLF BALLS:** The Local Rule for Conforming Driver Heads is in effect, See Model Local Rule G-1. The Local Rule requiring that all golf balls used be on the List of Conforming Golf Balls is in effect. See Model Local Rule G-3. [Please check the USGA web site for a list of approved golf balls and drivers.](#) The “One Ball Rule” is in effect. See Model Local Rule G-4.
- LOCAL RULES:** A pair of rules documents pertinent to this qualifier are available for review prior to this competition. Link here to access the [USGA’s Local Rules & Terms of the Competition](#) and the [Notice to Players \(specific to qualifying at Indian Trails Country Club\)](#).
- PACE OF PLAY:** Participants must play without undue delay and in accordance with pace of play guidelines [established by the NGA attached here](#).
- EVACUATION PLAN:** In the event of a discontinuance of play during the qualifier, players must [adhere to the evacuation plan attached here](#).
- COVID GUIDELINES:** The qualifying web site includes information on any guidelines associated with this qualifier. [You can also access them by linking here](#).
- ELECTRONIC SCORING:** To assist with real-time scoring we ask that one individual (player/caddie) in each group enter player’s scores after each hole. [Link here to access information on downloading the USGA TM App for score entry](#).
- PLAY-OFF:** In the event of a tie for the last qualifying place, or either of the alternate positions, there will be a hole-by-hole play-off to determine place winners and alternates. Any announcements regarding the play-off will be made at the public scoreboard upon completion of the qualifying round.
- QUALIFIER PLACES:** The field of 17 will compete for 2 qualifying places and 2 alternate positions.
- LOWEST SCORE:** Silver medal, if a tie, duplicate medals will be awarded.
