- ACCOMMODATIONS:** Because of the large number of lodging options available in Omaha there are no hotel arrangements made for this qualifier.
- PRACTICE ROUNDS:** See attached Page 3
- STARTING TIMES:** Starting times will begin at 7:30 a.m. off No. 1
- PRACTICE FACILITIES:** Practice areas will open at 6:30 a.m. Range balls are complimentary and will be available on the practice tee.
- REGISTRATION:** Registration will be located outside the golf shop entrance beginning at 6:30 a.m. Players are required to check in prior to their starting time.
- FOOD & BEVERAGE:** The 19th Hole snack bar will be available for food and beverage service throughout the day. The restaurant will also be open upstairs following play. Credit/Debit card purchases only (no cash).
- LOCKER ROOM:** You may use the locker room but individual lockers are not available.
- CADDIES:** A player may provide his own caddie. *Exception: A player may NOT use a parent, step-parent, or a guardian as a caddie.*
- TRANSPORTATION:** Transportation is prohibited during the round. Players and caddies shall walk at all times during the stipulated round unless otherwise specified by the Committee. Pull/push carts are permitted.
- SPECTATORS:** Spectators are allowed and encouraged to follow a golfer. Per USGA guidelines, the use of golf carts for spectators is prohibited.
- GROOVE STANDARDS:** It is a requirement that a player's clubs conform to the groove specifications provided in the Rules of Golf. An Equipment Database is found at usga.org.
- RANGEFINDERS:** The use of Distance Measuring Devices is permitted.

- DRESS CODE:** Players and caddies must be neat in appearance with respect to clothing and personal grooming.
- FOOTWEAR:** Local Rule as prescribed in Section 8 of the Committee Procedures is in effect. Model Local Rule G-7.
- GOLF BALLS:** Any ball used in making a stroke must be on the current List of Conforming Golf Balls issued by the USGA. The list is regularly updated and is found at usga.org. The **"One Ball Rule"** is in effect, see Model Local Rule G-4.
- PACE OF PLAY:** Qualifying participants must play at a prompt pace of play and in accordance with guidelines included in the post deadline packet.
- EVACUATION PLAN:** In the event of a suspension of play during the qualifier, players must adhere to the evacuation plan included in the post deadline packet.
- PLAY-OFF:** In the event of a tie for the last qualifying place, or either of the alternate positions, there will be a hole-by-hole play-off to determine place winners and alternates. Any announcements regarding the play-off will be made at the public scoreboard upon completion of the qualifying round.
- QUALIFIER PLACES:** Qualifying places will be announced after the May 26 deadline.
- LOWEST SCORE:** Silver medal, if a tie, duplicate medals will be awarded.
