CHAMPIONSHIP WEB SITE

Complete championship information is available at the official Nebraska Match Play Championship web site – <u>https://www.nebgolf.org/nebraskamatchplay</u>. Included are links to tournament history, course set-up, groupings and starting times, real-time scoring updates and the match play bracket.

PRACTICE ROUNDS

Practice rounds will be available beginning May 1st. To make arrangements for a practice round no more than one week in advance at a time convenient to Riverside GC players must contact the golf shop at (308) 382-2648. Practice round rate is \$44+tax (walking) or \$64+tax (w/ cart).

REGISTRATION

Registration will be located near the entrance to the golf shop and cart staging area on Monday, june 20th from 7:00 a.m.-10:00 a.m. (A.M. Wave) and 12:00 p.m.-3:00 p.m. (P.M. Wave). Players **ARE REQUIRED** to check in prior to starting their first round.

<u>CARTS</u>

Automotive transportation (cart) is permitted. If a player has not pre-registered for a cart he should contact the NGA office to make a reservation because sufficient carts may not be available. <u>Maximum of two (2) carts per</u> group will be allowed. Under no circumstances will three (3) carts be allowed in a group. Players should expect to be paired up for cart use. Caddies will be asked to walk if carts are occupied by players.

CADDIES

Caddies are permitted.

PRACTICE FACILITIES

Practice areas will open one hour before the first start time each day of the Championship. Practice balls are complimentary and will be available on the practice range.

FORMAT

A) Stroke Play – 36-holes stroke play to determine 32 qualifiers for match play. A tie for the last qualifier's place shall be decided immediately by a hole-by-hole play-off beginning on hole #1 unless otherwise determined by the Committee.

MONDAY, JUNE 20, 18-holes TUESDAY, JUNE 21, 18-holes

B) Match Play – General numerical draw will be used. For purposes of determining places in the draw, ties in qualifying rounds shall be decided by a blind draw, except that places of those participating in a play-off shall be determined by the order on the public scoreboard summary and by performance in the play-off.

WEDNESDAY A.M., JUNE 22, First Round, 18-holes WEDNESDAY P.M., JUNE 22, Second Round, 18-holes THURSDAY A.M., JUNE 23, Quarterfinal Round, 18-holes THURSDAY P.M., JUNE 23, Semifinal Round, 18-holes FRIDAY, JUNE 24, Final, 36-holes

In the event of a tied match, (a) the winner shall be decided immediately by a hole-by-hole play-off and (b) the stipulated round is deemed to extend to as many holes as are required for a match to be won.

SCORING

Scorecards will be used during the championship. Either one player or caddie in each group will be required to enter hole-by-hole scores digitally via an electronic device (cell phone) through the Golf Genius app. Players are asked to download the Golf Genius app prior to the start of their first round. Complete instructions on how to download the Golf Genius app, login, and keep score will be at the starter's table. Upon completion of the round players will enter the designated scoring area to review, verify and sign their scorecards.

PRIZES

WINNER: Custody of championship trophy, gold medal, championship money clip and a framed match play bracket.

RUNNER-UP: Trophy and silver medal.

LOWEST QUALIFYING SCORE: Bronze medal; if a tie, duplicate medals will be awarded. MERCHANDISE PRIZES: To Be Determined.

SPECTATORS

Spectators are allowed. <u>Spectator carts **WILL NOT**</u> be available during the stroke play qualifying rounds of the championship. Carts will be allowed, based on availability, for spectators to rent during the match play rounds.

FOOD & BEVERAGE

The clubhouse will be open for food and beverage service each day. The club accepts cash and credit cards as a method of payment.

ON-COURSE AMENITIES (WATER & SNACKS)

Bottled water will be available for players and caddies before your round on #1 and #10 tees, as well as, the #5 and #14 tees. Snacks, i.e. fruit, energy bars, etc. will be available on the #1 and #10 tees.

FOOTWEAR

Riverside Golf Club is a spikeless club and, therefore, spiked shoes will not be allowed. Penalty for breach of the spikeless rule is disqualification.

PERSONAL EFFECTS

Please take care of your valuables. Neither Riverside Golf Club nor the NGA can assume responsibility for articles lost or stolen.

STARTING TIMES

See the pairings link on the championship web site for your assigned starting tee and time for both rounds of stroke play qualifying. Match play seedings and match starting times will be available following the stroke play qualifying rounds. It is your responsibility to be present at your assigned starting tee and ready to play at the assigned time.

SCORE POSTING

All scores will be posted for handicap purposes. Players should not post these scores individually.

NOTICE OF WITHDRAWAL
