ACCOMMODATIONS: See qualifying website for lodging options.

PRACTICE ROUNDS: Practice Rounds are available for a fee of \$33 (walking) or \$50 (with cart). On Mon-

day, June 13, due to an outing at the club, practice rounds will not be available until about 4 p.m. or later. Please contact the golf shop at Lochland Country Club -

(402) 462-8783 to arrange a time.

STARTING TIMES: Starting times will begin at 8 a.m. off No. 1

PRACTICE FACILITIES: Practice areas will open at 7 a.m. Range balls are complimentary and will be

available on the practice tee.

REGISTRATION: Registration will be located outside the golf shop beginning at 7 a.m. Players are

required to check in prior to their starting time.

FOOD & BEVERAGE: The clubhouse will be available for food and beverage service throughout the day.

CADDIES: A player may provide his own caddie. *Exception: A player may NOT use a parent,*

step-parent, or a quardian as a caddie.

TRANSPORTATION: During the round, a player or caddie must not ride on any form of motorized

transportation except as authorized or later approved by the Committee. A player who will play, or has played, under penalty of stroke and distance is always authorized to ride on motorized transportation. Pull/push carts are permitted.

SPECTATORS: Spectators are allowed and encouraged to follow a golfer. Per USGA guidelines,

the use of golf carts for spectators is prohibited.

GROOVE STANDARDS: It is a requirement that a player's clubs conform to the groove specifications

provided in the Rules of Golf. An Equipment Database is found at usga.org.

RANGEFINDERS: The use of Distance Measuring Devices is <u>permitted</u>.

DRESS CODE: Players and caddies must be neat in appearance with respect to clothing and

personal grooming.

FOOTWEAR: Local Rule as prescribed in Section 8 of the Committee Procedures is in effect.

Model Local Rule G-7.

GOLF BALLS: Any ball used in making a stroke must be on the current List of Conforming Golf

Balls issued by the USGA. The list is regularly updated and is found at usga.org.

The "One Ball Rule" is in effect, see Model Local Rule G-4.

PACE OF PLAY: Qualifying participants must play at a prompt pace of play and in accordance with

guidelines included in the post deadline packet.

EVACUATION PLAN: In the event of a suspension of play during the qualifier, players must

adhere to the evacuation plan included in the post deadline packet.

PLAY-OFF: In the event of a tie for the last qualifying place, or either of the alternate

positions, there will be a hole-by-hole play-off to determine place winners and alternates. Any announcements regarding the play-off will be made at the public

scoreboard upon completion of the qualifying round.

QUALIFIER PLACES: The field of 17 players will compete for 1 spot and 2 alternate positions.

LOWEST SCORE: Silver medal, if a tie, duplicate medals will be awarded.
