- ACCOMMODATIONS:** See qualifying website for lodging options.
- PRACTICE ROUNDS:** Practice Rounds are available for a fee of \$33 (walking) or \$50 (with cart). On Monday, June 13, due to an outing at the club, practice rounds will not be available until about 4 p.m. or later. Please contact the golf shop at Lochland Country Club - (402) 462-8783 to arrange a time.
- STARTING TIMES:** Starting times will begin at 8 a.m. off No. 1
- PRACTICE FACILITIES:** Practice areas will open at 7 a.m. Range balls are complimentary and will be available on the practice tee.
- REGISTRATION:** Registration will be located outside the golf shop beginning at 7 a.m. Players are required to check in prior to their starting time.
- FOOD & BEVERAGE:** The clubhouse will be available for food and beverage service throughout the day.
- CADDIES:** A player may provide his own caddie. *Exception: A player may NOT use a parent, step-parent, or a guardian as a caddie.*
- TRANSPORTATION:** During the round, a player or caddie must not ride on any form of motorized transportation except as authorized or later approved by the Committee. A player who will play, or has played, under penalty of stroke and distance is always authorized to ride on motorized transportation. Pull/push carts are permitted.
- SPECTATORS:** Spectators are allowed and encouraged to follow a golfer. Per USGA guidelines, the use of golf carts for spectators is prohibited.
- GROOVE STANDARDS:** It is a requirement that a player's clubs conform to the groove specifications provided in the Rules of Golf. An Equipment Database is found at usga.org.
- RANGEFINDERS:** The use of Distance Measuring Devices is permitted.

- DRESS CODE:** Players and caddies must be neat in appearance with respect to clothing and personal grooming.
- FOOTWEAR:** Local Rule as prescribed in Section 8 of the Committee Procedures is in effect. Model Local Rule G-7.
- GOLF BALLS:** Any ball used in making a stroke must be on the current List of Conforming Golf Balls issued by the USGA. The list is regularly updated and is found at usga.org. The **"One Ball Rule"** is in effect, see Model Local Rule G-4.
- PACE OF PLAY:** Qualifying participants must play at a prompt pace of play and in accordance with guidelines included in the post deadline packet.
- EVACUATION PLAN:** In the event of a suspension of play during the qualifier, players must adhere to the evacuation plan included in the post deadline packet.
- PLAY-OFF:** In the event of a tie for the last qualifying place, or either of the alternate positions, there will be a hole-by-hole play-off to determine place winners and alternates. Any announcements regarding the play-off will be made at the public scoreboard upon completion of the qualifying round.
- QUALIFIER PLACES:** The field of 42 players will compete for 2 spots and 2 alternate positions.
- LOWEST SCORE:** Silver medal, if a tie, duplicate medals will be awarded.
