NOTICE TO PLAYERS

(This information supplements the Local Rules and Terms of Competition for NGA Championships)

1. Abnormal Course Conditions including Ground Under Repair:

- a. Include but are not limited to:
 - i) Decorative flower and plant beds.

2. Immovable Obstructions:

- a. Include but are not limited to:
 - i) All artificially surfaced roads and paths, including any adjacent curbing.
- b. Immovable obstructions adjacent to, within or abutting each other, such as artificially surfaced paths (including decorative areas enclosed by these paths), curbing, walls, steps and drains, are considered a single obstruction.
- c. Permanent restrooms and structures, including adjacent and surrounding artificially surfaced paths, patios, fences and decorative plantings, are considered a single obstruction.

3. Movable Obstructions: Include but are not limited to:

- i) Staking and roping; trash cans; benches; and beverage coolers.

4. Out of Bounds:

- a. Defined by the perimeter fence, white stakes and white lines.
- b. Hole #14 - Out of bounds is defined by the course side edge of the sidewalk along the right side of the hole and behind the putting green.

5. Penalty Areas:

- a. **Dropping Zones** - If a ball is in the following penalty areas, including when it is known or virtually certain that a ball that has not been found came to rest in the penalty area, the player has these relief options, each for one penalty stroke:
 - i) proceed under Rule 17.1; or
 - ii) as an additional option, drop the original ball or another ball in the dropping zone (marked "DZ") in the location below. The dropping zone is a relief area under Rule 14.3
 - Hole #14 Yellow Penalty Area - DZ located in the fairway.
- b. When playing Hole #7 the Yellow Penalty Area right of the green is to be played as a Red Penalty Area.

- 6. **Play-Off:** In the event of a play-off to determine the champion, play will commence from the 17th hole immediately following the conclusion of the final round. The play-off routing will be holes 17 & 18 repeated until the champion is determined.

- 7. **Scoring Area:** A scorecard is returned when the player has left the scoring area defined by blue dots.

8. Teeing Area:

- a. Championship Division - Red NGA tee markers.
- b. Tournament Division - White NGA tee markers.

9. Temporary Immovable Obstructions (TIOs): Model Local Rule F-23 is in effect. TIOs include: scoring tents and sponsor signs.

- a. Special Relief Procedure - **Either Side Relief:**
 - i) If a player is allowed relief under the TIO Local Rule, the player may take relief without penalty on either side of the TIO.

- 10. **Paint Dots and Lines Not Used for Course Marking:** Blue dots are used to define the scoring area. Free relief is NOT available.

- 11. **Pace of Play Review Committee:** Justin Ahrens, Craig Ames and Sam Oehm.

- 12. **Final Decisions on Disputed Points** will be made by Justin Ahrens, Craig Ames and Sam Oehm.
