- ACCOMMODATIONS:** Due to the abundance of hotel options in nearby (10-15 minutes) Kearney, there is no official lodging arrangements.
- PRACTICE ROUNDS:** Practice Rounds are available for a fee of \$20 (walking) or \$42 (with cart), at a time convenient to the club. Please contact the golf shop at Awarii Dunes - (308) 743-1111 to arrange a time.
- STARTING TIMES:** Starting times will begin at 8 a.m. off No. 1 & No. 10
- PRACTICE FACILITIES:** Practice areas will open at 7 a.m. Range balls are complimentary and will be available on the practice tee.
- REGISTRATION:** Registration will be located outside the golf shop entrance beginning at 7 a.m. Players are required to check in prior to their starting time.
- FOOD & BEVERAGE:** The clubhouse will be available for food and beverage service throughout the day.
- CADDIES:** A player may provide his own caddie. *Exception: A player may NOT use a parent, step-parent, or a guardian as a caddie.*
- TRANSPORTATION:** During the round, a player or caddie must not ride on any form of motorized transportation except as authorized or later approved by the Committee. A player who will play, or has played, under penalty of stroke and distance is always authorized to ride on motorized transportation. Pull/push carts are permitted.
- SPECTATORS:** Spectators are allowed and encouraged to follow a golfer. Per USGA guidelines, the use of golf carts for spectators is prohibited.
- GROOVE STANDARDS:** It is a requirement that a player's clubs conform to the groove specifications provided in the Rules of Golf. An Equipment Database is found at [usga.org](https://www.usga.org/equipment).
- RANGEFINDERS:** The use of Distance Measuring Devices is permitted.

DRESS CODE:	Players and caddies must be neat in appearance with respect to clothing and personal grooming.
FOOTWEAR:	Local Rule as prescribed in Section 8 of the Committee Procedures is in effect. Model Local Rule G-7.
GOLF BALLS:	Any ball used in making a stroke must be on the current List of Conforming Golf Balls issued by the USGA. The list is regularly updated and is found at usga.org .
PACE OF PLAY:	Qualifying participants must play at a prompt pace of play and in accordance with guidelines included in the post deadline packet.
EVACUATION PLAN:	In the event of a suspension of play during the qualifier, players must adhere to the evacuation plan included in the post deadline packet.
PLAY-OFF:	In the event of a tie for the last qualifying place, or either of the alternate positions, there will be a hole-by-hole play-off to determine place winners and alternates. Any announcements regarding the play-off will be made at the public scoreboard upon completion of the qualifying round.
QUALIFIER PLACES:	47 layers will be competing for two (2) qualifying and two (2) alternate places.
LOWEST SCORE:	Silver medal, if a tie, duplicate medals will be awarded.
