NOTICE TO PLAYERS

(This information supplements the Championship entry & The Local Rules and Terms of the Competition for 2024 NebGolf Championships)

- 1. Abnormal Course Conditions:**
 - a. Ground Under Repair:
 - i. Decorative Flower and Plant Beds (including decorative rock borders). When enclosed by cart paths or adjacent to immovable obstructions, they are a single abnormal course condition. (Exception – there is no relief for the decorative bed behind hole #2.)
- 2. Immovable Obstructions:** Include but are not limited to:
 - a. Decorative rock adjacent to artificially surfaced roads and paths.
 - b. Immovable Obstructions adjacent to each other are to be treated as a single obstruction.
 - c. Immovable Obstructions Close to Putting Green - Model Local Rule F-5 is in effect. Relief is only available when both the obstruction and the ball lie in a part of the general area cut to fairway height or less.
- 3. Integral Objects** include:
 - a. Stone walls located within the margin of Penalty Areas.
- 4. Out of Bounds:**
 - a. Defined by the perimeter fence posts and white paint lines in addition to white stakes.
 - b. Where a boundary has both white stakes and a white paint line, the white paint line defines the boundary, and the white stakes are immovable obstructions.
 - c. Defined by the course side edge of the road behind hole #2 and right of and behind hole #9. A ball is out of bounds when all of it lies beyond the concrete edge, even though it may lie on another part of the course.
 - d. Hole #14 - a ball is out bounds when it is beyond the ditch left of the hole and on homeowner's property.
- 5. Penalty Areas:**
 - a. Dropping Zones: If a ball is in the following penalty areas, including when it is known or virtually certain that a ball that has not been found came to rest in the penalty area, the player has these relief options, each for one penalty stroke: 1) Take relief under Rule 17.1; or 2) As an extra option, drop the original ball or another ball in the dropping zone marked "DZ" in the location below. The dropping zone is a relief area under Rule 14.3.
 - i. Hole #2 Yellow Penalty Area - Drop Zone located on the forward tee.
 - ii. Hole #10 Yellow Penalty Area and Red Penalty Area Right of the Putting Green – Drop Zone located in the fairway.
- 6. Teeing Ground:**
 - a. The Red NebGolf tee markers define the teeing ground for the Women's Amateur Championship.
 - b. The White NebGolf tee markers define the teeing ground for the Women's Senior Amateur Championship.
- 7. Starting and Scoring Areas:** Defined by blue paint dots.
- 8. Play-Off:** In the event of a tie for the championship, there will be a hole-by-hole playoff to determine the winner. All announcements regarding the play-off will be made near the practice green upon completion of the qualifying round. The play-off rotation will be holes 10,11,17 & 18 repeated, unless otherwise determined by the Committee.
- 9. Temporary Immovable Obstructions:** Relief on Either Side. Model Local Rule F-23 is in effect and includes starting and scoring tents. If a player has either physical interference or line of sight interference from any TIO and is entitled to relief, as an additional option, he may take relief on the other side of the TIO along the arc without penalty. When taking relief on the other side of the TIO, the player may only take relief under the TIO Local Rule, not Rule 16.1.
- 10. Paint Dots Not Used for Course Marking:** Blue paint dots used to define the edges of the starting and scoring areas. Relief without penalty is NOT available from these dots.
