NOTICE TO PLAYERS – DRAFT VERSION (9/11/24)

(This information supplements the Local Rules and Terms of the Competition for 2024 NebGolf Championships)

1. **Advice:** Model Local Rule H-2 is in effect. Each team may name two advice givers whom players on the team may ask for advice and receive advice from during the round, so long as:
 - a. Each advice giver is designated by the institution's athletic department to perform coaching duties; and
 - b. They must be identified to NebGolf before any player on the team begins their round; and
 - c. They must wear the identification band provided by NebGolf.
2. **Transportation:** Model Local Rule G-6 is in effect. During the round, a player must not ride on any form of motorized transportation except as authorized or later approved by the Committee. A player who will play, or has played, under penalty of stroke and distance is always authorized to ride on motorized transportation.
3. **Caddies:** Model Local Rule H-1.1 is in effect. Rule 10.3a is modified in this way:
 - a. A player must not have a caddie during the round.
4. **Play-Off:** In the event of a tie for the team champion in each division, there will be a hole-by-hole play-off, scoring all five scores on each hole until a winner is determined. The play-off rotation will be holes #1, #2, #14, #15 and #16. In the event of a tie for the individual champion in each division, there will be a hole-by-hole play-off until a winner is determined. The play-off rotation will be holes #17 and #18 repeated.
5. **Teeing Area:**
 - a. Red NebGolf Tee-Markers define the teeing area for the men.
 - b. White NebGolf Tee-Markers define the teeing area for the women.
6. **Scoring Area:** A score card is returned when it has been given to the scoring official and the player has left the scoring area.
7. **Out of Bounds:**
 - a. In addition to white stakes, out of bounds is defined by white lines and dots.
 - b. Hole #1 - Out of bounds is defined by the wood fence posts right of the green, in addition to white lines.
 - c. Hole #4 - Out of bounds is defined by white stakes along the left side during play of that hole only.
 - d. Hole #6 - Out of bounds is defined by white stakes behind the green. A ball coming to rest beyond the white stakes is out of bounds, even if it comes to rest on another part of the course that is in bounds for other holes.
 - e. Hole #7 - Out of bounds is defined by the wood posts along the left side, in addition to white stakes.
 - f. Holes #10 & #13 - The driving range on the right side, defined by white stakes, is out of bounds.
 - g. Hole #18 - Out of bounds is defined by white stakes along the right-side during play of that hole only.
8. **Ground Under Repair** includes but is not limited to:
 - a. Decorative flower beds.
9. **Immovable Obstructions:**
 - a. Include but are not limited to:
 - i. All artificially surfaced roads and paths, including any adjacent curbing.
 - ii. Young trees defined by white tubing and/or stakes.
 - b. Immovable obstructions adjacent to, within or abutting each other, such as artificially surfaced paths (including decorative areas enclosed by these paths), curbing, walls, steps and drains, are considered a single obstruction.
 - c. Clubhouse, pool, permanent restrooms and pump house, including adjacent and surrounding artificially surfaced paths, curbing, walls, steps, patios, fences and/or decorative plantings, are considered a single obstruction.
 - d. White Stakes used to define out of bounds along the left of hole #4 and the right of hole #18 are deemed to be immovable obstructions during play of any other hole.
10. **Immovable Obstructions Close to Putting Greens:** Model Local Rule F-5 is in effect. Relief is only available when both the obstruction and the ball lie in a part of the general area cut to fairway height or less.
11. **Penalty Areas:**
 - a. Dropping Zones - If a ball is in the following penalty areas, including when it is known or virtually certain that a ball that has not been found came to rest in the penalty area, the player has these relief options, each for one penalty stroke: proceed under Rule 17.1; or as an additional option, drop the original ball or another ball in the dropping zone (marked "DZ") in the location below. The dropping zone is a relief area under Rule 14.3
 - i. Holes #3, #8 & #18 Red Penalty Area - DZ located on a forward tee.
12. **Temporary Immovable Obstructions:** Relief on Either Side. Model Local Rule F-23 is in effect and includes starting and scoring tents. If a player has either physical interference or line of sight interference from any TIO and is entitled to relief, as an additional option, they may take relief on the other side of the TIO along the arc without penalty. When taking relief on the other side of the TIO, the player may only take relief under the TIO Local Rule, not Rule 16.1.
