NOTICE TO PLAYERS

(This notice supplements the Local Rules and Terms of Competition for NebGolf Championships)

1. Abnormal Course Conditions:

- a. Mulch bases of trees are considered an abnormal course condition.

2. Immovable Obstructions:

- a. Include but are not limited to:
 - i.) The clubhouse area (including clubhouse, cart barn, patio and other adjacent immovable artificial objects).
 - **Dropping Zone:** Hole #15 - If a ball is in the clubhouse area defined above, including when it is known or virtually certain that a ball that has not been found came to rest in this area, the player has these free relief options: 1) Take relief under Rule 16.1; or 2) As an extra option, drop the original ball or another ball in the dropping zone marked "DZ" behind the green. The dropping zone is a relief area under Rule 14.3.
- b. Artificially surfaced roads and paths include those surfaced with crushed rock, gravel, asphalt or mulch.
- c. Immovable obstructions within or adjacent to each other are to be treated as a single obstruction.
- d. If there are damaged areas adjacent to cart paths, these areas are considered part of the obstruction.

3. Movable Obstructions:

- a. Include but are not limited to:
 - i.) Staking and roping; trash cans; benches; and beverage coolers.

4. Out of Bounds:

- a. In addition to the perimeter fence and white stakes, out of bounds is defined by:
 - i.) The curbing of the entrance road on hole #1 and left of hole #4. A ball that crosses the course side edge of a road or a curb defined as out of bounds and comes to rest beyond the road or curb is out of bounds, even if it comes to rest on another part of the course that is in bounds for other holes.
 - ii.) The course side edge of the public walking path left of hole 8, behind hole 10 and left of hole 11.
 - iii.) The course side edge of the parking lot left of hole #14.
 - iv.) The fence posts left of hole #15.
 - v.) The course side edge of the concrete entrance circle.

5. Penalty Areas:

a. Dropping Zones:

- i.) If a ball is in the following penalty areas, including when it is known or virtually certain that a ball that has not been found came to rest in the penalty area, the player has these relief options, each for one penalty stroke: 1) Take relief under Rule 17.1; or 2) As an extra option, drop the original ball or another ball in the dropping zone (marked "DZ") in the location below. The dropping zone is a relief area under Rule 14.3.
 - Hole #8 Red Penalty Area in Front of the Green – DZ located in the fairway.
 - Hole #13 Between the Red Penalty Area Stakes with White Stripe Tops – DZ located in the rough.

6. Temporary Immovable Obstructions: Model Local Rule F-23 is in effect. TIOs include but are not limited to: tents and championship signage.

a. Special Relief Procedure - Either Side Relief:

- i) If a player is allowed relief under the TIO Local Rule, the player may take relief without penalty on either side of the TIO.

7. Deciding Ties: In the event of a tie for first place, there will be a hole-by-hole play-off following completion of the final round. The play-off rotation will be holes #16-17-18, unless otherwise notified by the Committee.

8. Scoring Area: A score card is returned when it has been given to the scoring official and the player has left the immediate scoring tent area.

9. Teeing Area:

- a. White NebGolf tee-markers define the teeing area for the girls.
- b. Red NebGolf tee-markers define the teeing area for the boys.

10. Caddies: A player may provide their own caddie. Caddies are required to wear a caddie bib. **Exception: A player may not use a parent or guardian as a caddie.**

11. Transportation: During the round, a player or caddie must not ride on any form of motorized transportation except as authorized or later approved by the Committee. A player who will play, or has played, under penalty of stroke and distance is always authorized to ride on motorized transportation. Players and caddies may accept transportation between #18 green and #1 tee.

13. Final Decisions on Disputed Points will be made by Justin Ahrens, Juliana Botero and Ben Vigil.
