NOTICE TO PLAYERS

(This information supplements the Championship entry & the Local Rules and Terms of the Competition for 2024 NebGolf Championships)

1. Abnormal Course Conditions include:

a. Decorative Flower and Plant Beds. When enclosed by cart paths or adjacent to immovable obstructions are treated as a single abnormal course condition.

2. Immovable Obstructions:

a. Birdhouses and their posts are immovable obstructions.

b. Staked Trees (including wire and mulched tree wells associated with staked trees) are deemed to be immovable obstructions.

c. Immovable obstructions adjacent to each other are to be treated as a single obstruction.

3. Loose Impediments:

a. Wood chips, pine straw and mulch are loose impediments.

4. Movable Obstructions: include, but are not limited to:

a. Staking and roping; trash cans; benches; and beverage coolers.

5. No Play Zone:

a. Turf Nursery located right of hole #18 is a No Play Zone that is treated as an abnormal course condition. Such nursery is not defined, but it constitutes all the area cut at approximately putting green height or less. Relief must be taken from interference by the no play zone under Rule 16.1f.

6. Out of Bounds:

a. Defined by the perimeter fence posts, white dots and white lines in addition to white stakes.

b. Defined by the pool fence between white stakes near the clubhouse.

7. Paint Dots and Lines Not Used for Course Marking:

a. Blue paint dots are used to define the scoring areas. Free relief is not available.

8. Penalty Areas:

a. The yellow penalty area on hole #15 plays as a red penalty area during play of any other hole.

b. Dropping Zones: If a ball is in the following penalty areas, including when it is known or virtually certain that a ball that has not been found came to rest in the penalty area, the player has these relief options, each for one penalty stroke: 1) Take relief under Rule 17.1; or 2) As an extra option, drop the original ball or another ball in the dropping zone marked "DZ" in the location below. The dropping zone is a relief area under Rule 14.3.

- i. Hole #1 Yellow Penalty Area Drop Zone located near the yellow penalty area.
- ii. Hole #5 Yellow or Red Penalty Area Drop Zone located on the forward teeing area.
- iii. Hole #6 Yellow or Red Penalty Area Drop Zone located on the forward teeing area.
- iv. Hole #7 Red Penalty Area Drop Zone located on the white teeing area.
- v. Hole #10 Yellow Penalty Area Drop Zone located near the yellow penalty area.
- vi. Hole #13 Yellow Penalty Area Drop Zone located in the fairway.

9. Temporary Immovable Obstructions: Model Local Rule F-23 is in effect. TIOs include but are not limited to: tents, fan near #11 green.

- Special Relief Procedure Either Side Relief:
 - If a player is allowed relief under the TIO Local Rule, the player may take relief without penalty on either side of the TIO.

10. Teeing Area:

- a. Women's Amateur Red NebGolf tee-markers define the teeing area.
- b. Women's Senior Amateur White NebGolf tee-markers define the teeing area.
- 11. Scoring Area: A scorecard is returned when the player has left the scoring area defined by blue dots.
- 12. Deciding Ties: In the event of a tie for the championship only, there will be a hole-by-hole playoff to determine the winner. The play-off rotation will be holes 18, 10, 16, 17 & 18 repeated, unless otherwise determined by the Committee.
- 13. Pace of Play Reviews: Justin Ahrens, Craig Ames, and Ben Vigil.
- 14. Final Decisions on Any Disputed Points: Justin Ahrens, Craig Ames, and Ben Vigil.
