NOTICE TO PLAYERS

(This information supplements the Championship entry & the Local Rules and Terms of the Competition for 2025 NebGolf Championships)

1. Abnormal Course Conditions includes:

a. Decorative flower beds (including all rock beds).

2. Immovable Obstructions:

- a. Include but are not limited to:
 - i) Artificially surfaced roads and paths including those surfaced with crushed rock, gravel and asphalt.
 - ii) Decorative rocks.
- b. Immovable obstructions adjacent to, within or abutting each other, such as artificially surfaced paths (including decorative areas enclosed by these paths), curbing, walls, steps and drains, are considered a single obstruction.
- c. Permanent restrooms and structures, including adjacent and surrounding artificially surfaced paths, patios, and decorative plantings, are considered a single obstruction.
- d. Young trees identified by an orange stake are deemed to be an immovable obstruction.

3. Movable Obstructions: include, but are not limited to:

a. Staking and roping; trash cans; benches; and beverage coolers.

4. Penalty Areas:

- a. The yellow penalty area on Hole #13 plays as a red penalty area during the play of any other hole.
- b. **Dropping Zones** If a ball is in the following penalty areas, including when it is known or virtually certain that a ball that has not been found came to rest in the penalty area, the player has these relief options, each for one penalty stroke:
 - i) proceed under Rule 17.1; or
 - ii) as an additional option, drop the original ball or another ball in the dropping zone (marked "DZ") in the location below. The dropping zone is a relief area under Rule 14.3
 - Hole #8 Yellow Penalty Area DZ located on the forward tee.
 - Hole #13 Yellow Penalty Area DZ located on the forward tee.
 - Hole #17 Red Penalty Area DZ located on the forward tee.

5. Out of Bounds:

- a. Defined by white lines in addition to white stakes, white paint dots and fence posts.
- 6. Temporary Immovable Obstructions: Model Local Rule F-23 is in effect. TIOs include but are not limited to: NebGolf tents.
 - a. Special Relief Procedure Either Side Relief:
 - i) If a player is allowed relief under the TIO Local Rule, the player may take relief without penalty on either side of the TIO.
- 8. **Deciding Ties:** In the event of a play-off to determine the champion, there will be a hole-by-hole play-off following completion of the final round. The play-off rotation will be holes 1, 17 and 18, unless otherwise notified by the Committee.
- 9. Scoring Area: A score card is returned when it has been given to the scoring official and the player has left the scoring area defined by blue dots.
- 10. Teeing Area: White NebGolf tee-markers.
- 11. Pace of Play Review Committee: Justin Ahrens, Craig Ames and Ben Vigil.
- 12. Final Decisions on Disputed Points will be made by Justin Ahrens, Craig Ames and Ben Vigil.
