**NOTICE TO PLAYERS**

(This information supplements the *Local Rules and Terms of Competition for NebGolf Championships*)

- 1. Championship Related Signs:** Signs that are fixed in the ground or on drive stakes are TIOs. Examples of these are tee signs, sponsor signs, informational signs, and when these are readily movable, they may be moved. If there is a drive stake, it remains a TIO.
- 2. Ground Under Repair and Other Abnormal Course Conditions:**
  - a. Include but are not limited to:
    - i) Decorative flower beds.
- 3. Native Grass:** Areas of native grass are considered part of the General Area.
- 4. Immovable Obstructions:**
  - a. Include but are not limited to:
    - i) All artificially surfaced roads and paths, including any adjacent curbing.
  - b. Immovable obstructions adjacent to, within or abutting each other, such as artificially surfaced paths (including decorative areas enclosed by these paths), curbing, walls, steps and drains, are considered a single obstruction.
  - c. Permanent restrooms and structures, including adjacent and surrounding artificially surfaced paths, patios, and decorative plantings, are considered a single obstruction.
  - d. The rock drain along the right of Hole #5.
  - e. The rock bed adjacent to the boundary fence behind the putting green on Hole #18.
- 5. Movable Obstructions: include, but are not limited to:**
  - a. Yardage posts.
  - b. Staking and roping; trash cans; benches; and beverage coolers.
- 6. Out of Bounds:** In addition to perimeter fences, white stakes, white paint dots and white lines, Out of Bounds is defined by:
  - a. The white line along the right side of Hole #1.
  - b. The inside (golf course) edge of the entrance road behind #5 Green, #7 Green and along the right of Holes #8 and #9.
  - c. The fence behind the putting green on Hole #18 in addition to white dots.
- 7. Play-Off to Determine Match Play Field:** In the event of a tie for the last spot(s) following stroke play qualifying, there will be a hole-by-hole play-off.
- 8. Match Tied after 18-Holes:** The match is extended one hole at a time in the same order as in the round until a winner is determined, unless otherwise stated by the Committee.
- 9. Scoring Area:** A scorecard is deemed to be returned when the player has left the scoring area defined by blue dots. Free relief from the blue lines is not available.
- 10. Teeing Area:**
  - a. Red NebGolf tee markers define the teeing area for the Championship Division.
  - b. White NebGolf tee markers define the teeing area for the Tournament Division.
- 11. Pace of Play Review Committee:** Justin Ahrens, Craig Ames, Juliana Botero and Ben Vigil.
- 12. Final Decisions on Disputed Points** will be made by Justin Ahrens, Craig Ames, Juliana Botero and Ben Vigil.
