### NOTICE TO PLAYERS

(This notice supplements the Local Rules and Terms of Competition for NebGolf Championships)

1. **Abnormal Course Conditions includes:**
  - a. Decorative flower beds.
  - b. Hole #7 - FC decorative bushes behind the putting green.
2. **Championship Related Signs:**
  - a. Signs that are fixed in the ground or on drive stakes are TIOs. Examples of these are tee signs, sponsor signs, informational signs, and when these are readily movable, they may be moved. If there is a drive stake, it remains a TIO.
3. **Immovable Obstructions**, include but are not limited to:
  - a. Artificially surfaced roads and paths including those surfaced with crushed rock, gravel and asphalt.
  - b. Immovable obstructions adjacent to, within or abutting each other, such as artificially surfaced paths (including decorative areas enclosed by these paths), curbing, walls, steps and drains, are considered a single obstruction.
  - c. Permanent restrooms and structures, including adjacent and surrounding artificially surfaced paths, patios, and decorative plantings, are considered a single obstruction.
  - d. Holes #3 & #7 - If the player's ball is past the wood "DROP" posts, the player may take free relief as stated under item 6.a below.
  - e. Holes #9 & #13 - If the protective fence intervenes with the player's line of play following the tee shot, the player may take free back-on-the-line relief.
  - f. Hole #11 - If the protective fence left of the fairway intervenes with the player's line of play during the play of #11, the player may take free relief by dropping a ball in the dropping zone.
4. **Integral Objects:**
  - a. Power outlets attached to trees.
5. **Movable Obstructions**, include, but are not limited to:
  - a. Yardage posts, staking and roping, trash cans, benches, and beverage coolers.
  - b. Wood posts used to define relief from protective fence.
6. **Protective Fences:**
  - a. Dropping Zones - If a ball has interference from the following protective fences, including line of play, the player has these free relief options:
    - i) proceed under Rule 16.1;
    - ii) take back-on-the-line relief; or
    - iii) as an additional option, drop the original ball or another ball in the dropping zone (marked "DZ") in the location below. The dropping zone is a relief area under Rule 14.3
      - Hole #3 Protective Fence - DZs located left of the fairway, right of the fairway and in the fairway. The player may drop in the closer of the three DZs.
      - Hole #7 Protective Fence - DZs located left of the fairway, right of the fairway and in the fairway. The player may drop in the closer of the three DZs.
      - Hole #11 Protective Fence - DZ located near the fence.
7. **Out of Bounds:**
  - a. Defined by the course side edge of perimeter fence posts, white stakes, and white dots.
  - b. Hole #18 – Out of Bounds right of the putting green is defined by the course side edge of the curbing between the white stakes.
8. **Temporary Immovable Obstructions:** Model Local Rule F-23 is in effect. TIOs include but are not limited to: fan behind Hole #14 and tents.
  - a. Special Relief Procedure - Either Side Relief:
    - i) If a player is allowed relief under the TIO Local Rule, the player may take relief without penalty on either side of the TIO.
9. **Scoring Area:** A score card is returned when it has been given to the scoring official and the player has left the scoring area defined by blue dots.
10. **Teeing Area:**
  - a. White NebGolf tee markers.
