The championship field will be limited to 120 players. If more than 120 entries are received by the July 7, 2026 deadline, the field will be comprised of players that filed entries by the deadline in these categories:

1. Winners of any of the following NebGolf Championships: Nebraska Amateur, Nebraska Match Play, Nebraska Mid-Amateur, Nebraska Senior Amateur & Nebraska Senior Match Play
2. Winners of the Gross Age Divisions of the Nebraska Senior Amateur Championship the last 3 years (2023-2025)
3. From the 2025 Nebraska Senior Amateur Championship, the lowest 10 scorers and anyone tying for 10th place
4. From the 2025 Nebraska Senior Match Play Championship, quarterfinalists of the Championship Bracket
5. From the NEBGOLF SENIOR POINT STANDINGS, the top 15 point leaders from the final point standings of 2025
6. Host Club Exemptions (2)
7. Remainder of the field determined by order of entry

\*Entry applications received by exempt players following the June 5, 2025 exempt player deadline will be processed under category 7 above.
